Environmental Commitment

We aim to reduce our greenhouse gas emissions by 20% and are actively protecting and supporting biodiversity. In alignment with these goals, we have set ambitious targets for 2024 and beyond, including:

- A 20% reduction in energy consumption.
- A 15% reduction in water usage.
- A 50% reduction in waste.
- A 100% reduction in the use of single-use plastics by 2030.

Since 2022, we have been gradually increasing our use of renewable energy. We are proud to have achieved that 25% of all our energy consumption now comes from renewable sources, and we continue to work towards further expansion of our renewable energy capacity.

To achieve our broader sustainability goals, we will continue to implement new initiatives starting in 2025, including installing additional solar panels, upgrading to LED lighting, and incorporating low-flow water-saving fixtures in our guest rooms and public areas. We encourage our guests, staff, and visitors to actively participate by following water and energy-saving guidelines and minimizing waste, as outlined throughout the property.

As part of our commitment to sustainability, Aleenta is proud to support the **Pure Blue Foundation**, which collaborates with local schools such as Khao Pilai and Wat Prachathikaram to provide resources including school materials, technology donations, financial assistance, and construction efforts.
